# A NOTE FROM CHAD

Greetings Friends and Supporters,

2024 was a transformative year for the TPA. We saw changes to our Board of Directors, including the retirement of our founder, Don Riggle, and the election of our President, Scott Bright, to the Colorado State Senate. These transitions brought shifts in duties and responsibilities, and the dedication of our Board was evident through their hard work. Notably, in addition to the Annual BoD retreat, we held a two-day immersive workshop in November, with Board members traveling from across the state to spend a total of two full days collaborating in person—no small feat for such a busy group!

As Executive Director, I couldn't be prouder of the Board's commitment. Their efforts not only kept us on track but also laid the groundwork for an organization that will thrive well into the future. These opportunities inspire us as we head into 2025, ready to advance responsible off-highway motorcycle access with renewed determination and purpose.

Beyond advocacy, our signature events thrived in 2024. The 5th Annual Partner Club Meeting, the Colorado 600, and the Moto Adventure Sweepstakes all exceeded expectations. Local clubs across Colorado also continued to step up, making a positive impact for motorized, multi-use trail users in their regions.

In short, 2024 was a year of growth and resilience for the TPA. As we embrace the new year, we're excited to launch new projects and expand our efforts to protect and create more off-highway motorcycle opportunities. None of this would be possible without your support—thank you for enabling us to make a difference.

#### 2nd Annual Retreat & Policy Governance Workshop

## INCOME & EXPENSE

The Trails Preservation Alliance is deeply grateful to our volunteers, donors, and industry supporters who share and champion our mission. Your contributions made 2024 a huge success—thank you for stepping up for off-highway motorcycle recreation!

In 2024, the TPA received an unexpected late-year donation, resulting in a larger-than-usual gap between income and expenses. 

# DEFENDING THE SPORT

The TPA actively provides professional feedback on land planning processes, supported by reviews from subject matter experts in areas such as GIS, wildlife, and engineering. #### **POSITIVE IMPACT**

#### **Progress at Penrose**

<u>Penrose Commons</u> saw an active and positive 2024, solidifying its status as a popular winter riding spot. The TPA and partner clubs participated in two events, with the second marking the official opening of three previously non-system trails! Colorado Motorcycle Trail Riders Association (CMTRA) secured a planning grant to advance more improvements to the riding area and we look forward to continued progress in 2025.

#### New Single-Track Access to the Rainbow Trail

TION

TPA partner club, Central Colorado Mountain Riders (CCMR), in collaboration with the Salida Ranger District, created a new single-track access point at Porter Gulch—providing entry to one of the most remote sections of the Rainbow Trail. Due to the difficult terrain, the trail has not been completed but is expected to be finished in the spring of 2025. This project enhances safety, improves access (including to Sangre de Cristo Wilderness trailheads above the Rainbow Trail), and expands recreation opportunities with better loop options for motorcyclists, e-bikes, and mountain bikes. The TPA supported the effort by participating in one of two workdays and helping coordinate with the contractor and donor for this privately funded project.



#### \$6.3 Million in OHV Grants at Work

OHV grants are essential for preserving motorized recreation, especially as federal land managers in Colorado face growing budget and staffing challenges. In many offices, these grants are the sole source of recreational funding—a situation expected to worsen in the coming years. The motorized community remains the only user group directly funding recreation at this scale. With support and guidance from the TPA numerous clubs across the state have been steadily increasing their participation in this program, applying for over 30% of the funding in the upcoming grant cycle!

### **Fully Funding Recreational Trails Program 2024**

TPA and our partners have been actively working to secure full funding for the Recreational Trails Program. This would increase federal funding for the CPW Trails Program from \$1.5 million to \$5 million annually by ensuring that the full amount of gas taxes paid by OHV and OSV users is returned to trail maintenance programs. We were pleased to see federal legislation on this issue introduced in 2024 and anticipate its reintroduction in 2025.

#### **SCORP Comments**

TPA and our partners are thrilled to have worked with CPW to update the Statewide Comprehensive Outdoor Recreation Plan, ensuring it remains focused on recreational priorities as Colorado's only statewide recreation plan. This plan is also crucial for securing funding from programs like the Land and Water Conservation Fund, as its periodic submission is required to maintain eligibility. Without it, critical funding could be lost. Read SCORP Comments.

#### **Colorado's Outdoors Strategy**

TPA contributed to the development of Colorado's Outdoors Strategy, a statewide vision that aligns common goals, supports regional initiatives, and provides data and tools for informed local decision-making and funding for conservation and outdoor recreation. We were pleased to have our Colorado Off-Highway Trail Opportunity Plan (COTOP) included in the strategy.

## **DEFENDING THE SPORT**

#### PERSISTENT CHALLENGES

#### Minnie Gulch Trail

As a brief recap, the 1.6-mile Minnie Gulch Trail, which connects two motorized routes over the Continental Divide between the Animas and Rio Grande River drainages, was improperly declassified for motorized use in 2010. It was later legally reinstated in the 2020 Silverton Travel Management Plan EA

Record of Decision by the BLM Gunnison Field Office.

While the BLM defended initially this decision, it was later reversed following the 2020 election amid significant external pressure. Extensive FOIA requests documented communications with BLM officials over the past three years suggest that this reversal was politically influenced and lacked policy-

based justification.

Angela Hixon & John Dourlet The TPA, San Juan Trail Riders, and Public Access Preservation Association remain committed to restoring motorized access to Minnie Gulch Trail. With upcoming changes in administration and federal BLM leadership, we are hopeful for a resolution.

Stay tuned, updates expected in early 2025!

#### Moab Labyrinth Rims/Gemini **Bridges TMP**

The BLM's closure of 317 miles near Moab in 2023 is being appealed by RwR, TPA, COHVCO, and CORE. Most of 2024 was spent challenging the completeness of the administrative record that likely influenced the decision. We are

> aware of correspondence between the decisionmaker and higherlevel BLM offices, including the deputy director, who previously represented the Wilderness Society in the 2017 settlement that led

> > to the TMP review. After negotiations, the BLM released more documents, aiding our appeal and the State of Utah/BRC federal case.

Additional records do exist, but early in 2025 we were notified our challenge for more records was denied and we plan to file our statement of reasons to the IBLA in early March. We remain optimistic that with an administration change we will reach a settlement and restore access for motorized recreation.

#### **National Monuments**

The continued misuse of the Antiquities Act to create massive National Monuments threatens recreation access, effectively establishing de facto wilderness. Recent designations in Utah span millions of acres, with the subsequent management plans further restricting multiple forms of recreation. The Act was intended to protect only the "smallest area compatible" with conservation needs, yet monument proposals keep expanding.

We appreciate our partner Clif Koontz, Executive Director of Ride with Respect, for his dedication to addressing these issues at every stage of the planning process. With shifting administrative priorities, we remain hopeful for more reasonable monument sizes and management strategies. Thankfully, a major monument proposal in Colorado last year did not move forward, and we continue to advocate for lasting reforms to prevent future misuse of the Antiquities Act.

#### **Utah Travel Management Plans**

In 2017, an agreement between SUWA, the BLM, and lawsuit intervenors (TPA, COHVCO, and BRC) required the BLM to redo Travel Management Plans (TMPs) in 13 travel management areas. Unfortunately, decisions released in late 2024 (on New Year's Eve) and early 2025 have resulted in the closure of more than 1,200 miles of roads and trails. A major issue with the TMP process is that it relies on incomplete inventories, which is unacceptable. Similar to the Moab case, these decisions are likely to be appealed by multiple pro-access organizations.

## RIDE ON!

Enhanced riding opportunities and improved experiences for riders stemming from TPA engagement. The section highlights the positive progress the TPA and our partners have made in 2024!

#### **EDUCATION**

TPA Executive Director Chad Hixon participated in the Chaffee County Visitors Bureau (CCVB) educational video on responsible off-highway motorcycle recreation. As part of their Adventure by Nature campaign, CCVB produced a series of educational videos promoting responsible recreation of all types that were shared via social media and email. TPA applauds CCVB for including all recreation types.



#### 2024 CLUB STATS & **VOLUNTEER HOURS**

TPA associated clubs made a tremendous impact on Colorado's trails in 2024, with their efforts growing significantly compared to previous years. While these clubs focus mostly on off-highway motorcycling, their volunteer work benefits all trail users—hikers, bikers, and equestrians alike—because motorized trails are multi-use by design. This year saw significant growth in volunteer hours, trail adoption, and funding utilization, demonstrating the dedication and expanding influence of these clubs in keeping trails open, safe, and well-maintained for everyone!

#### A NEW CHAPTER IN FEDERAL ADVOCACY

For the first time, the TPA is taking our advocacy to the national level with the support of a federal lobbyist. We're excited to partner with Erica Terguson of Crosswinds Solutions, who brings 20 years of experience navigating Washington, D.C. Erica has worked with the Appropriations and Natural Resources Committees, federal agencies, and key stakeholders to shape policy, secure funding, and protect access to public lands.

With increasing federal involvement in land management decisions, it's more important than ever to have a strong voice in D.C. This partnership ensures that motorized recreation is represented where it matters most—at the highest levels of government.

#### THE TPA TRAIL CREW LAUNCHES

In 2025, we are launching the TPA Trail Crew, a dedicated team of experienced professionals focused on improving trail maintenance across Colorado. Inspired by the USFS Statewide Trail

#### Crew, this team will be:

- Fully funded by the TPA for the first year
- Equipped with a truck, camper, motorcycles, chainsaws, PPE, and more
- Offering trail work services at little to no cost to public land management agencies

• Initially focused on handwork, the crew will also be qualified to operate machinery when needed. This initiative aims to address ongoing federal funding and staffing challenges, providing vital support for Colorado's trails.

To sustain this effort beyond 2025, we're pursuing a Colorado Parks and Wildlife (CPW) 2025–2026 OHV grant and building partnerships with agencies, clubs, and trail users statewide.


